

**TERMS & CONDITIONS FOR TRADING
BENEFITS/TERMENI SI CONDITII PENTRU

Definitions

1. “TeleTrade”: TeleTrade-DJ International Consulting Ltd, a limited liability Company registered as a Cyprus Investment Firm under registration number HE272810 and licensed by the Cyprus Securities and Exchange Commission under license number 158/11.
2. “Client”: A person who has entered into an agreement with TeleTrade, for investment and/or ancillary services which are authorized under TeleTrade’s license number 158/11 issued by CySEC, in accordance with the Legal documentation forming the Operative Agreement between the client and TeleTrade found at <http://www.TeleTrade.eu/about/regulating-documents>.
3. “Trading Benefits” shall include but not be limited to:
 - a. Compensation of transactional expenses: trading benefits that reimburse a certain proportion of client’s expenses related to depositing and withdrawal of funds and/or trading-related fees such as swaps, spreads and trading commissions, and that are extended in the form of cash rebates or account balance adjustments, as defined by specific compensation program;
 - b. “24% Reward Program”: trading benefit that pays back a certain percentage of the Client’s equity balances in active trading accounts on a monthly basis, as an incentive for maintaining the active status of the trading account.

Definitii

1. “TeleTRADE”: TeleTRADE-DJ International Consulting, companie inregistrata ca o companie infiintata in Cipru sub numarul de inregistrare HE 272810 si licentiata de Cyprus Securities and Exchange Commission sub numarul de licenta 158/11.

3. “Beneficiile de Tranzactionare” vor include dar nu se vor limita la:
 - a. c. “Loyalty Awards”: trading benefits in the form of cash payments that require a certain track record to be established with TeleTrade in the form of a specified amount of traded lots within the specified time period to become redeemable.

4. All terms contained herein shall bear the definition/ meaning given to them by the legal documentation forming the Operative Agreement between the client and TeleTrade found at

Eligibility for Trading Benefits

5. To be able to receive any trading benefits a new client must apply for a trading account with TeleTrade, and, after opening of the account, make a deposit in the trading account via the Personal Page at the website:

6. All applications for new clients to open a trading account will be evaluated by the Compliance Department once the client has provided all the required documentation properly and fully completed, and only once he/she passes the appropriateness and/or suitability test as warranted by the exact investment service that the Client applies for and is approved will the Client be eligible to receive the Trading Benefits.

7. TeleTrade trading benefit schemes may vary from country to country so for exact details of applicable benefits and promotions in your

Accrual, Payment and Use of Trading Benefits

8. Trading benefits in the form of compensation of transactional expenses are generally available for all eligible clients who have been awarded such benefits, and are applied without further specific conditions unless stated in the specific Trading Benefit offer.

9. Trading benefits in the form of Loyalty Awards are paid out once the required amount of traded lots has been achieved over the specified time period after the benefit has been extended to the Client, as stated in the applicable Loyalty Awards offer which the client agrees to. At redemption, such an award will be credited into the client's trading account in cash. The required amount of traded lots for redemption of the award can be found in the Client's Personal Login Page at the website: <https://my.TeleTrade.eu/> and/ or at the website: <http://www.TeleTrade.eu/>.

10. Trading benefits provided by the "24% Reward Program" shall be credited in cash to the Client's trading account after the required amount of traded volume of lots per month is achieved. Acumulare, Plati si Utilizarea Beneficiilor de Tranzactionare

16. 17. - d. the Client, by himself or acting with others, having an account or accounts where the accumulated Trading Benefits from other offers or promotions in the account is greater than the amount which could have been
